BRIEF HISTORY OF THE COLLEGE



The D.H.S.K. Law College is a premier and prestigious Law College of Upper Assam under Dibrugarh University which was established in the Year 1965 . The College has a glorious past of its own. On 26th December 1964 , the Governing Bodies of D.H.S.K. Kanoi College , D.H.S.K. Commerce College and M.D.K Girls College held a joint meeting and passed a resolution for establishment of a Law College at Dibrugarh from July ,1965 to fulfill the long standing Public demand.

Initially, the college did not have its own building and it had to start functioning from the premises of D.H.S.K. Commerce College. Later, with the financial assistance of Late Rai Sahib H.B Kanoi, a plot of land measuring 8 Bighas , 4 Kathas and 10 Lesses was purchased in the name of D.H.S.K. Law College and the building of the present Law College at Red Cross Road was constructed in the year 1989 .

The Dibrugarh Hanumanbax Surajmal Kanoi Law College made a humble beginning with a handful of student in 1965 . Thereafter the college had never looked behind and has produced more than thousands of lawyers in the entire North East India. Amongst these, many legal luminaries ,distinguished judges and outstanding alumni's are the pride of this college.

Hon'ble Mr. Justice Amitava Roy, Hon'ble Judge of Supreme Court of India (Rtd), is an Alumni of this prestigious institution who completed his LL.B Degree from this College. During his tenure as a S.C. Judge he has delivered the landmark judgements like Shyam Narayan Chouksey v Union of India, State of Karnataka v Selvi J. Jayalitha, Yakub A. R. Memon v State of Maharashtra etc.

Dr. (Mrs) Indira Shah, a distinguished alumni of this College was appointed as Registrar General of Gauhati High Court on 01.11.2011 who was later elevated to the post of Judge of Gauhati High Court. It is worth mentioning that she was the first lady Registrar General and High Court Judge who was evaluated from the Judicial Service.

INFRASTRUCTURE AND FACILITIES OF THE COLLEGE

CLASS ROOM

The College provides adequate infrastructure facilities of the education process to enhance the learning ability of the students. It aims at developing intellectual capabilities and an understanding of the relationship between education and the real world. A well equipped resource generation room is set-up for the faculty to prepare their lectures and carry out various academic activities in their subjects. The college also has a dedicated seminar hall to conduct various sessions conducted by eminent speakers and other academic activities.



COMPUTER LABORATORY

The well-equipped computer laboratory with high speed internet connectivity enhances the learning process with the aid of E resources.

LIBRARY

Library is the heart of a law institute. The library of our college consists of Books, Periodicals, All India Reporters, Journals, Magazines and Newspapers. Apart from text books of law Curriculum the library has other collection like reference volumes, books on career guidance, competitive examinations, general knowledge, dictionaries, question papers of all semesters, book review etc. The library has a separate spacious reading room attached to the lending section. Through our library, we are earnestly committed to enhance the quality of learning and research by continuously updating our resources and services.



24 HOURS ELECTRICITY FACILITY

There is no problem of power cut in the college as because the college have its own generator to give backup power supply during departmental loadshedding by the electricity department. Separate power backup facility is provided centrally for uninterrupted teaching, learning and research and administrative work.

FILTERED DRINKING WATER FACILITY

The college has made all the necessary arrangements for providing clean and pure drinking water to the students and all staff. Each drinking water point has a branded water purifier for the uninterrupted supply of water. It is to ensure that the students and staffs of the college remain hydrated during scorching heat along with sound health. The Maintenance Committee regularly checks the functioning of water purifier. Proper repair and replacement are done in order to ensure pure and safe drinking water for all.

INFRASTRUCTURE AND FACILITIES OF THE COLLEGE

MOOT COURT

A moot court is like practicing mechanism for the real court, where students are made to participate in the staged court proceedings that are related to a fictitious dispute between parties. It is obligatory for the 3rd to 6th semester students to participate in internal moot court practice. Through this practice the law students get a forum to mould their legal diagnostic, research, analytical and writing skills that lawyers and advocates must have. The College has its own well furnished moot court imparting practical legal training to the students guided by experienced practicing advocates having more than 28 years of experience in both civil and criminal matters.



CAFETERIA

A spacious cafeteria is setup within the college building devoted to the refreshment service of the students and staff. It provides food items at reasonable rates prefixed by the college authority for the benefit of the stakeholders.

CC T.V. SURVEILLANCE

CC T.V. monitoring is a common requirement today in all places and hence the college had installed CC T.V. cameras in various nook and corner of the college including the classrooms so that everything is monitored and student feel safe.

PARKING FACILITY

The College has a separate parking facility in the campus for both two wheelers as well as four wheelers. The facility can be availed by the staff as well as students.



LEGAL AID CLINIC

IQAC AND VARIOUS OTHER CELLS, CLUB & COMMITTEES

INTERNAL QUALITY ASSURANCE CELL (IQAC)

In accordance with the NAAC guidelines, the Internal Quality Assurance Cell (IQAC) was established to initiate, monitor, evaluate and report on relevant measures to upgrade the quality of teaching, learning, evaluation and research initiatives in the college. The IQAC has been constituted with principal, faculties at all levels, few members from the society, representatives from the management, representative from student and few Independent external members. The primary aim of our IQAC is :

- To develop a system for conscious, consistent and catalytic action to improve the academic and administrative performance of the institution.
- To promote measures for institutional functioning towards quality enhancement through internalization of quality culture and institutionalization of best practices.

LEGAL AID CLINIC

Legal Aid Clinic is a Student run Body under the able guidance of the Faculty-in-Charge cum Vice-Principal of the College which offers legal and para-legal services. The Faculty-in-Charge is assisted by the other members of the clinic which include Senior Faculty, Advocates, PLV etc. It has at win mandate of spreading legal awareness and providing free legal assistance to the socially and the economically backward sections of the society who have difficulty in accessing the judicial system. Additionally, it also provides a centre for practical and professional training for students of law. To spread legal awareness, we regularly perform legal literacy programmes, distribute newsletters, pamphlets, etc., and undertake other projects to disseminate important points on the law among the public in multiple languages. As for providing aid, we help clients with a variety of problems in different legal areas including Family Law, Property Law, Criminal Law, Consumer Law, etc.

MOOT COURT SOCIETY

Mooting can best be described as an activity that comes closest to being a lawyer while still studying at law school. It involves identifying legal issues out of a complex factual scenario, doing exhaustive research on those issues to advance arguments with authorities, followed by drafting extensive written submissions and finally the gruelling orals before a bench of eminent judges. In a nutshell, it is everything a lawyer is expected to do once he starts practising law. The Moot Court Society of the college is the student committee entrusted with the responsibility of administering and facilitating all mooting related activities at D.H.S.K. Law College. The society is run under the guidance of a senior faculty member designated as Faculty in charge.

ANTI-RAGGING COMMITTEE AND SQUAD

The D.H.S.K. Law College has zero tolerance on ragging. Ragging is strictly banned on campus and can attract serious repercussions from the College administration. Ragging is a criminal offence and is governed by the Anti-Ragging Code of the University Grants Commission (UGC). The Anti-Ragging Committee and Squad was formed in the college with the object of ensuring that the UGC framed regulations on prohibition, prevention, and elimination of ragging are strictly followed on campus.

HEALTH AND ECO-CLUB

The Health and Eco-Club is a means by which the students can organize themselves to learn more about healthy life and environmental issues, and also take appropriate action to improve their immediate environment. For teachers, it is a wonderful opportunity to create awareness, build attitudes and help students to take up activities in real world, in a way in which the constraints of the classroom and curriculum will not allow. This club create awareness and sensitivity among individuals and social groups to the total environment and its allied. In order to coordinate the activities of the club, a senior faculty is designated as the Nodal Officer.

SC/ST/OBC/MOBC AND MINORITY CELL

This cell is a mechanism to prevent indulgence of employees in any kind of discrimination against students and staff belonging to SC/ST/OBC/MOBC & Minority categories. The Cell is committed to provide assistance to the SC/ST & minority students through counseling, personality development, development of communication skill, remedial coaching, tutorial classes, and preparatory classes for professional and employment purposes, etc. The Cell is actively engaged in coordinating and resolve the problems in the matter of conduct of remedial coaching and other measures with a view to see that the education system succeeds in bringing the scheduled castes, scheduled tribes and minorities to a level quantitatively as well as qualitatively indistinguishable from the level of the rest of the society.

STUDENTS' GRIEVANCE REDRESSAL CELL

The main objective of the Grievance Cell is to promote and maintain a conducive and harmonious educational environment among the students. The Students' Grievance Cell is constituted for the redressal of the problems reported by the students of the College. The cell functions to look into the grievances lodged by any student. Students may approach the cell to voice their grievances regarding academic matters, health services, library and other services. EXAMINATION AND ATTENDANCE COMMITTEE

Examination and Attendance Committee is a body which is authorized to look after examination as well as attendance in the college. Its primary duty is to conduct examinations held by the College and make policy decisions in regard to organizing and holding examinations, improving systems of examinations, moderations etc..

LIBRARY DEVELOPMENT COMMITTEE

Apart from it the committee prepares the annual plan for the college which include academic developmental activities.

DETAILS FOR ADMISSION

ELIGIBILITY

Admission to the 3 Year LL.B Courses is purely on merit basis following the reservation criteria. The following qualifications are required for different categories :

GENERAL : Minimum 45% marks in Bachelor Degree or equivalent from any recognized University.

OBC/MOBC : Minimum 42 % marks in Bachelor Degree or Equivalent from any recognized University.

SC/ST : Minimum 40 % marks in Bachelor Degree or Equivalent from any recognized University.

Documents to be submitted along with the Admission Form in Two Sets :

1. Self attested copy of Admit Card, Marksheet and Pass Certificate of H.S.L.C Certificate or Equivalent Certificate.
2. Self attested copy of Admit Card, Marksheet and Pass Certificate of Higher Secondary Examination or Equivalent.
3. Self attested copy of Admit Card, Marksheet and Pass Certificate of Bachelor Degree Examination or Equivalent.
4. Self Attested Copy of University Registration Card or migration certificate (whichever applicable).
5. Self Attested Copy of Caste Certificate (SC/ST/OBC/MOBC).

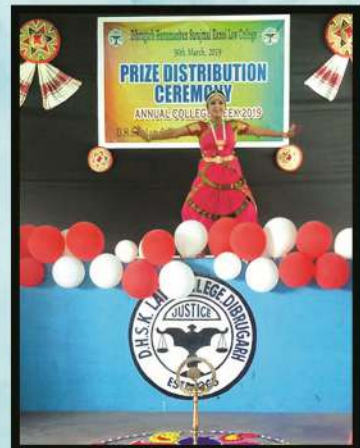
